### Biography

Carrie also regularly advises on family matters involving contentious divorces, disputes over the custody of children, the relocation of children, maintenance, family violence/protection orders and maintenance claims. Carrie is also proficient in Syariah Court matters involving Muslim divorces, custody disputes and assets division.

Carrie's notable cases include the seminal Court of Appeal decision in the landmark case of ANJ v ANK – [2015] 4 SLR 1043, that prescribed the structured approach that is adopted in almost all subsequent cases dealing with the division of matrimonial assets, the Court of Appeal decision in USB v USA and another appeal – [2020] 2 SLR 588M, the High Court decisions in URU v URV – [2019] 3 SLR 1045 UFU (M.W.) v UFV – [2017] SGHCF 23, TZG v TZH – [2017] SGHCF 9, ACY v ACZ – [2014] 2 SLR 1320, BND v BNE – [2014] SGHC 30 and BJV v BJW – [2013] SGHC 140, amongst other noteworthy cases.

Carrie brings equal skills to courtroom advocacy and mediation, offering clients a flexible approach to dispute resolution. She is committed on empathy towards her clients and to advocating persuasively for her clients before the Courts.
