Since joining HEP Law in 2022, Nadeeya has been key in expanding the firm's dispute resolution capabilities. She has represented clients across a broad spectrum of civil and commercial disputes. Her experience includes acting for government-linked companies in arbitration as well as representing international oil and gas companies in contentious matters arising from their Brunei operations.

## Experience
